Legal Information System (RIS)

DIGITAL 🚪 AUSTRIA

- German abbreviation for "RechtsInformationsSystem" (legal information system)
- service for citizens, business and administration
- electronic database operated by the Federal Chancellery; available on the Internet since 1997
- information platform on the current law in the Republic of Austria
- publication of the Federal Law Gazettes
- Free of charge

FEDERAL CHANCELLERY



- 1983: decision within the Federal Chancellery to build up the RIS, first concepts
- 1986: beginning of data input first contents: law of the civil servants
- First technical platform: IBM host system
- Access first only for BKA internal; later for the whole administration (Intranet)
- Some parts of the RIS contents were made available for public by RDB (private company) and (the former) Official Printing Office (1991)
- June 1997: public access via Internet; and Intranet (for the administration) version
- 2008: Large Relaunch







- 2008: RIS Relaunch
 - data management in XML
 - New modern layout according to international accessibility standards (eg WAI)
 - representation of tables and graphics
 - better readable fonts (new font Verdana instead of Courier)
 - representation of the documents in 3 file formats (HTML, PDF, RTF)
 - Easy and advanced search functions
 - better highlighting of search phrases within the text
 - create current version of legal act for any date







- 39 different databases
- Individual search forms for each application
- General search like Google for citizens (available from August)
- Accessible to people with disabilities (WAI-A according to WCAG 1.0)
- No complicated query language







- Availability of three different file formats (RTF, PDF and HTML)
- High performance search with MS SQL Server 2008
- All documents are public, the decisions of the courts are anonymous
- Online help and comprehensive manuals for each application







- Supported browsers: IE 6.0 upwards, Firefox 3.0 upwards and Opera 10.x
- Contact points for questions (technical & content)
- No complicated query language
- Developed with Microsoft .NET 3.5
- Free of charge
- Possible access with mobile devices (e.g. Smart phones)







- It's possible to set external hyperlinks to each RIS document
- Hyperlinks to external web sites (e.g. Parliament, Regional Governments)
- About 90 important Ferderal Laws are translated into English http://www.ris.bka.gv.at/Englische-Rv/
- Catalog of Hyperlinks to e.g. Austrian ministries, EU bodies, law relevant web sites

 - Environmental Tribunal
 - Federal Communications Board
 - Procurement Review Authorities
 - Appeals Tribunal and Supreme Disciplinary Commission

Authentic version of the Gazette DIGITAL AUSTRIA

- Some additional information of each Gazette e.g. title, date of publication, number of Gazette
- Electronic signature (XML file)
- Some Gazettes are composed of several documents (e.g. annexes)
- Several file formats (PDF, HTML, RTF, signed version)

Selection of RIS applications:

- Federal Law Gazettes (authentic) 5.200 documents
- Federal Law Gazettes (not authentic) 32.800 documents
- Federal Law consolidated version 297.000 documents
- Jurisdiction of the 3 high courts in Austria 598.000 documents (decisions)

- Federal Law Gazettes (not authentic) 134.000 document accesses
- Federal Law consolidated version 37.842.345 document accesses
- Jurisdiction of the 3 high courts in Austria 2.340.000 document accesses
