# **REINTEGRATION PROGRAMME Joint Reintegration Services**

JRS in a nutshell

Active since 1 April 2022

Currently active in 37 countries of origin

**26 Member States** 

**5 Reintegration Partners** contracted for 4 years

Fully financed by Frontex – zero costs for Member States Case management done in **GPDR compliant**environment (RIAT)

Assistance in **Post- arrival and post- return**

(3 days after arrival)



- Airport pick-up or reception at place of arrival
- Temporary accommodation
- In-country travel assistance
- Referrals for urgent medical care



### Geographical coverage of the JRS

Albania, Algeria, Armenia, Bangladesh, Brazil, Egypt, El Salvador, Ethiopia, Georgia, Ghana, Guinea, India, Iraq, Moldova, Mongolia, Morocco, North Macedonia, Nigeria, Pakistan, Somalia, Sri Lanka, The Gambia, Türkiye, Vietnam.

TC covered, under the JRS, added from 1 April 2023: Serbia, Tunisia, Kosovo, Tajikistan, Jordan, Palestine, Somaliland, Kazakhstan, Cameroon, Kyrgyzstan, DR Congo (Kinshasa), Nepal, Kenya. For Afghanistan, Russia, Ukraine, Syria services are not active, but could be activated if the situation improves.



### **Eligibility of returnees**

As a rule: eligibility criteria is dependent on the MS' national regulations

JRS is open for voluntary and forced returnees

Cases can be inserted retroactively (within 6 months)

TCN who refuse to sign an application for reintegration can receive an eligibility letter in order to get support after arrival (both VR and FR)

Legal stay under Directive 2011/95/EU

Temporary protection within the meaning of Directive 2001/55/EC

Roles and Responsibilities

#### Frontex

Acting as the Support Desk (Central Administrative Function)

Manages legal and financial commitments

Quality monitoring

Direct contact points for MS and RPs

Ensuring full operational engagement of MS

#### **Member States**

Inserts cases into RIAT

Ensures eligibility of TCN

Ensures returnees are well informed about reintegration

Verifies and approves reintegration plan in KM 2 and completion of cases in KM 3

## Reintegration Partners

Ensures the delivery of qualitative reintegration

If applicable (sub-) contracts internal or external organizations to ensure reintegration assistance




Total cases: 6 616
